

Observations Completed During 2023-2024 Academic Year


A. The learning objectives were: aligned to the College and Career Ready Standards, appropriate for the subject and grade level, measurable, and aligned with the learning tasks.


B. Articulated the learning objective(s), provided clear directions and explanations, and logically sequenced the learning experience.






E. Differentiated instruction to accommodate for differences in individual needs, abilities, interests and learning styles.


F. The lesson was relevant for learners with clear connections to prior knowledge and future learning.


G. Engaged students in critical thinking that promoted problem solving and conceptual connections.






J. Integrated appropriate technology that was relevant to the learning objectives and actively engaged the students in demonstrating knowledge/skills.


K. Managed a respectful and safe classroom environment conducive for learning.


